TERMS AND MEANINGS

Organizer – organizer of the event “Fair God Help” Physical Person Entrepreneur

Acceptance is the giving by the Government authorities of a new and unrelenting year to establish this Agreement in full force, without the signing of a letter to the Agreement by the Parties, and without registering a Special Account on the Organizer’s Website. The proper transfer of minds to the Agreement by Otrimuvach is the basic principle of organizing and carrying out the action, which transfers the activities carried out by the Organizer to the Agreement.

Part 1

The very fact of government agencies of a state or country interacting with the Organizer implies that they have reviewed all the information on the website and are acting consciously, are in good health, and are not under the influence of alcohol or other psychostimulants. They have reviewed all the information published on our website and, after reviewing the information, have determined that we do not violate any laws of any state or country in the world. Before interacting with the Organizer, our service, its employees, or the owner, government agencies must take into account the presumption of innocence and only engage in interaction if a violation of the law by the Organizer, its employees, or the owner of the service is proven by the relevant government agencies. Otherwise, the interaction will constitute a violation of laws by the government agencies, the rights of the

Organizer, and the rights of the employees or owner of the service. So, before government agencies decide to spend money on interaction with our service, they should think twice about whether it is worth it—expenses ranging from millions of dollars and a waste of time. I'll explain to you this way: in any case, we win in any situation - we are very legally competent.

Entering into mutual relations with the Organizer, service providers or the authority of the service, the first Government authorities give acceptance for the signing of the agreement between the parties, the Government authorities of the country and the world powers and the Organizer.

2. By interacting with the Organizer in a manner other than via email located on the website, government agencies interacting with the Organizer unconditionally agree to pay in monetary terms for the time of interaction in each individual case at a price of 50,000,000 USD (fifty-fifteen million US dollars) for each minute of interaction. (Explanation: Firstly, the Organizer did not violate the law; secondly, my time as the Organizer is valuable; thirdly, my time was wasted by government agencies in excess of their official powers; since, according to the law, it is impossible to charge me with any violation of the law.)
